# Currently: II – Management of the club and paragraph 3 and III Meetings - paragraph 1

3 Assets of The Club. A record of all receipts and expenditure to be kept in recognised books of Account (including electronic). The Honorary Treasurer is authorised to make Transactions on their sole authority from the Club's 'Current Account', provided always that any payments are made for the bona fide benefit of The Club and that any payment above £1000 to be agreed with either The Commodore or The Honorary Secretary.

### **III Meetings**

1 The Annual General Meeting of the Club for passing the accounts, electing Officers .... and accompanied by a copy of the accounts made up to September 30th and signed by the auditors, shall be sent to every Member resident in the United Kingdom.
